



European Union is made of citizens and for its citizens!

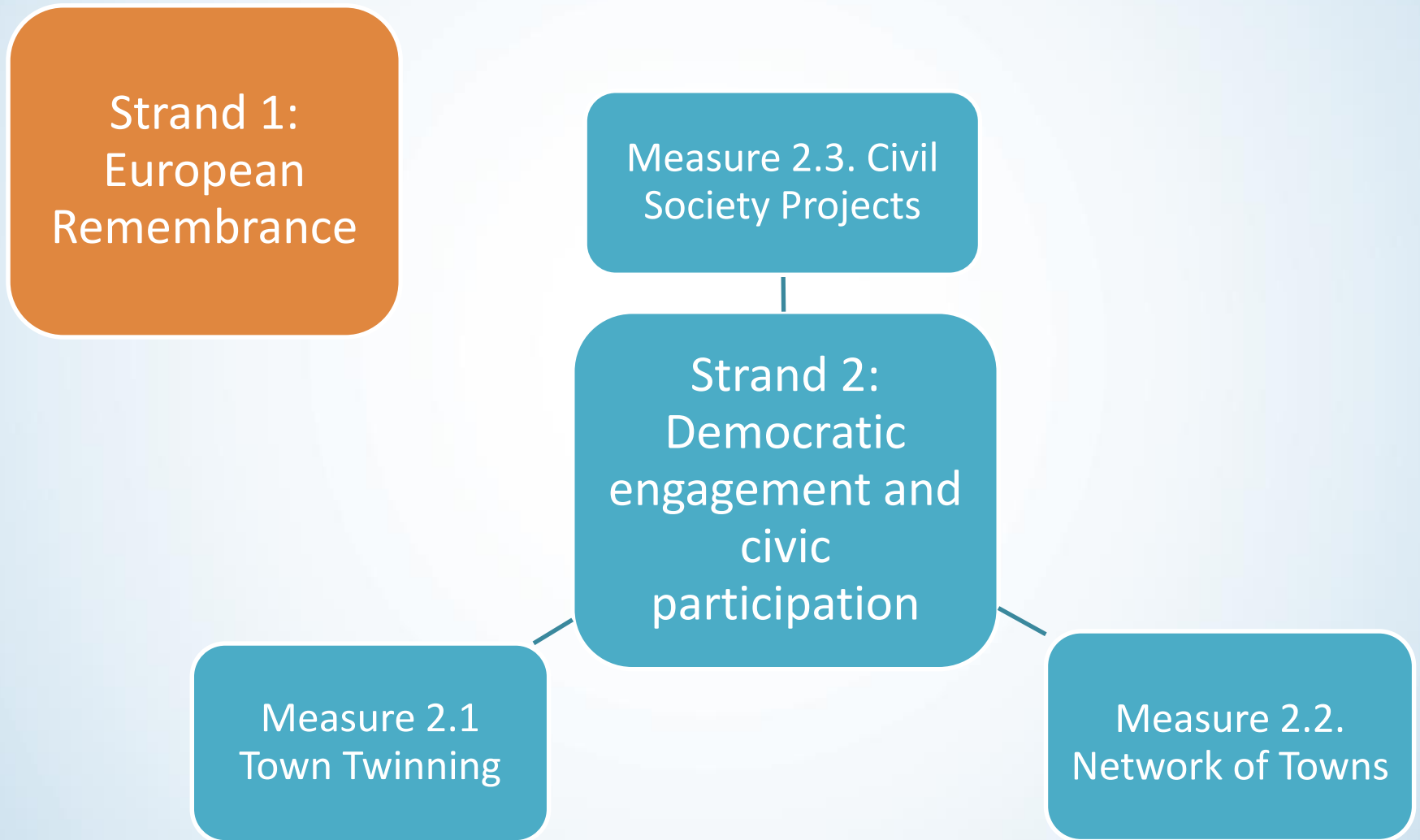

Structure of the Programme 2014 – 2020



Strand 1: European Remembrance

- **Eligible applicants and partners:**

Public / regional authorities or non-profit organizations, including civil society organizations, associations of survivors and cultural organizations, youth organizations, educational and research organizations.

- **Number of Partner:**

The project must include organizations from at least 1 Member state. Preference is given to transnational projects.

- **Maximum grant amount:** 100.000 EUR
- **Pre-financing:** 40-60%
- **Max project duration:** 18 months

Strand 2: Democratic engagement and civic participation

Measure 2.1 Town Twinning

- **Eligible applicants and partners:**

Towns/municipalities or their twinning committees or other non-profit organizations representing local authorities.

- **Number of Partners:**

A project must involve municipalities from at least 2 eligible countries of which at least one is an EU Member State.

- **Number of participants:**

A project must involve a minimum of 25 invited participants. "Invited participants" are international participants sent by the eligible partner/s.

- **Maximum grant amount:** 25.000 EUR

- **No pre-financing**

- **Max duration of implementation (meeting):** 21 days

Strand 2: Democratic engagement and civic participation

Measure 2.2 Network of Towns

- **Eligible applicant and partners:**

Towns/municipalities or their twinning committees or networks; Other levels of local/regional authorities; Federations/associations of local authorities. Non-profit organizations representing local authorities. The other organizations involved in the project can also be non-profit civil society organisations.

- **Number of Partners:**

A project must involve municipalities from at least 4 eligible countries of which at least 2 are an EU Member State. At least 30% of the projects' participants travel from eligible Programme countries to the country/ies hosting Networks of Towns events.

- **Venue and number of activities:**

The activities must take place in different eligible partner countries. At least 4 events per project have to be foreseen.

- **Maximum grant amount:** 150.000 EUR
- **Max pre-financing:** 40-60%
- **Max duration of implementation:** 24 months

Strand 2: Democratic engagement and civic participation

Measure 2.3 Civil Society Projects

- **Eligible applicant and partners:**

Non-profit organizations, including civil society organizations, educational, cultural or research institutions, other organizations involved in the project can also be public local/regional authorities.

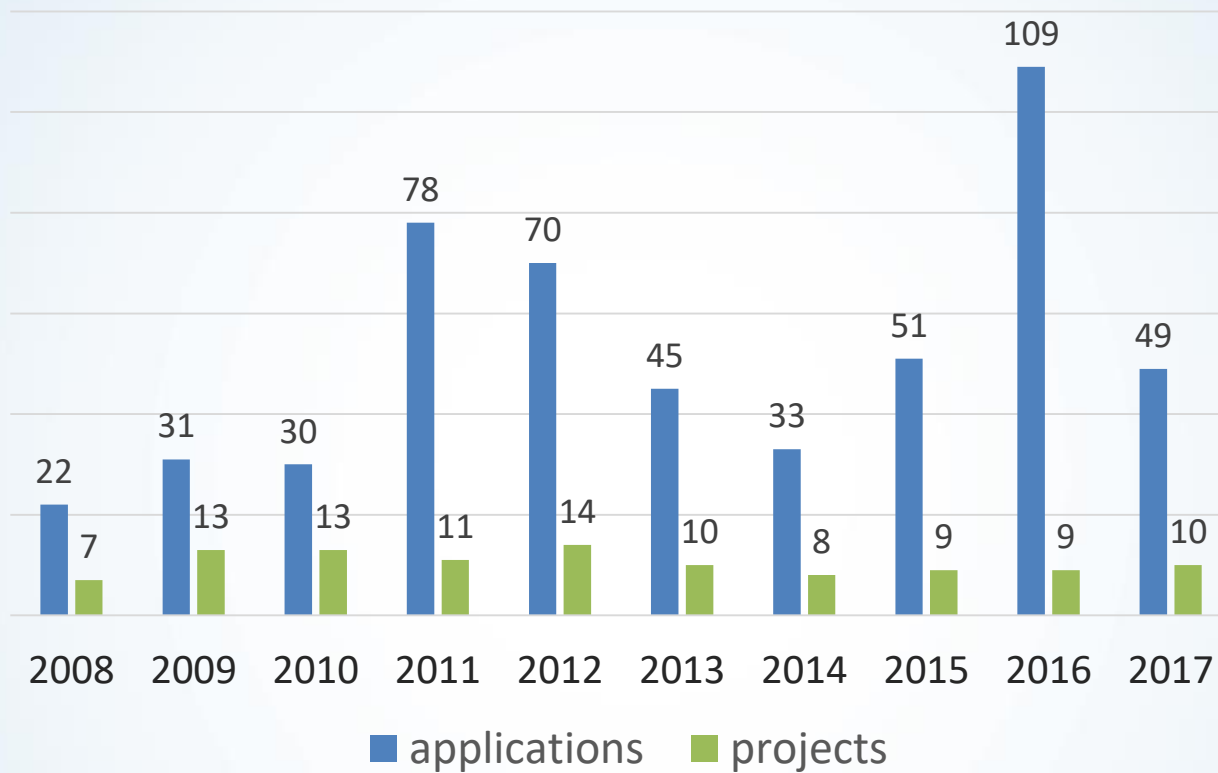
- **Number of Partners:**

A project must involve organizations from at least 3 eligible countries of which at least two are an EU Member State.

- **Venue of activities:**

The activities must take place in any of the eligible countries.

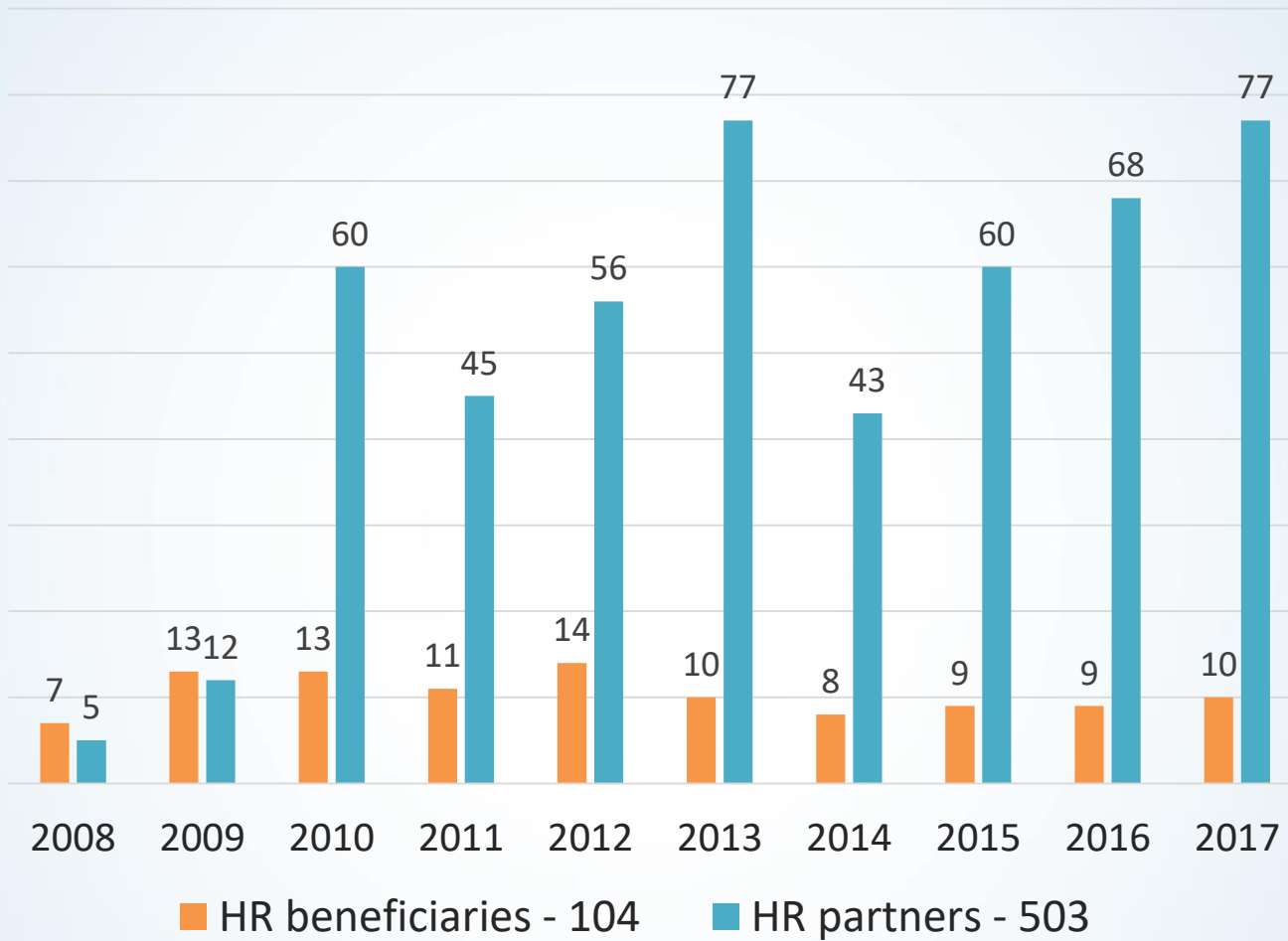
- **Max grant amount:** 150.000 EUR
- **Max pre-financing:** 40-60%
- **Max project duration:** 18 months



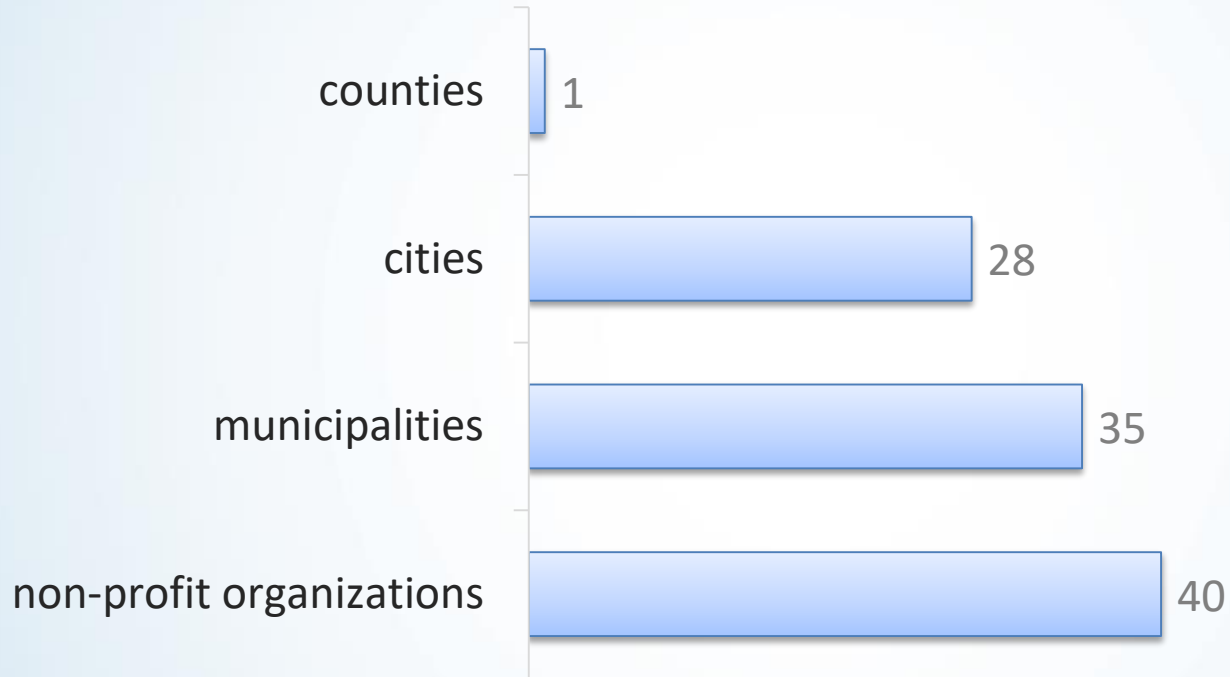
Total number of applications - 518

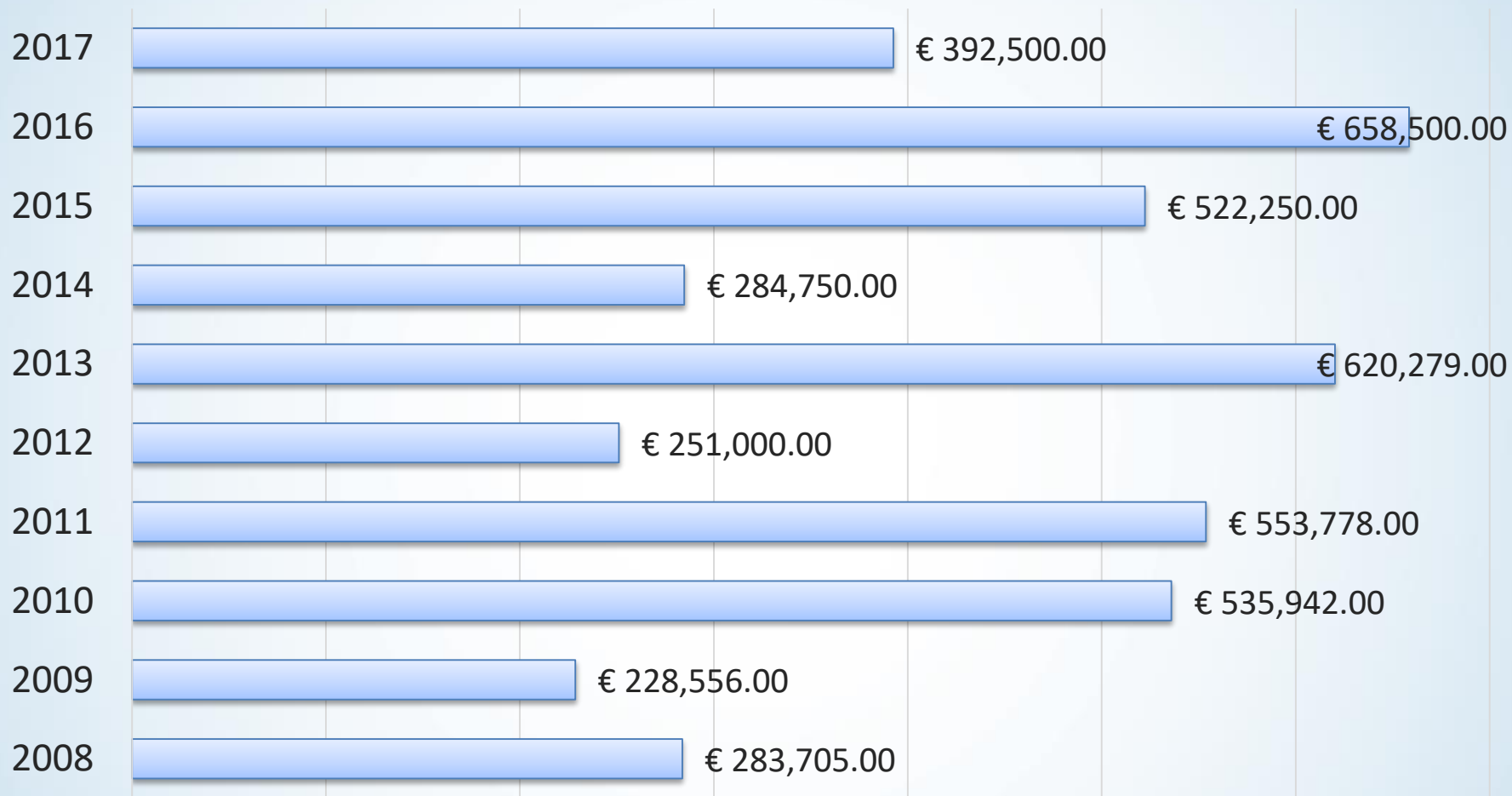
Total number of HR projects - 104
